By signing below, you agree with the following team requirements (as outlined in the Team Information Sheet):

- 1) HVB team registration and Middletown Parks & Rec. registration form must be completed and on file prior to entering the pool.
- 2) Each swimmer will be required to attend and compete in designated team meets.
- 3) **A \$56 US Swim registration fee (per swimmer)** will be paid at time of registration.
- 4) **A \$25 Team Administration Fee (per swimmer)** will be paid upon registration.
- 5) Team suit and cap are available directly through Speedo. Please see the Cudas' Equipment Manager for more information.
 - a. The Cudas will be using the same Speedo Galaxy suit from the 08-09 season. Returning swimmers are not required to purchase a new one, unless you would like to. It is strongly suggested that all new registrants purchase the team suit package. Please see a Board member for more details.
- 6) Middletown Parks and Recreation Supplemental Insurance Fee: \$10.00 Middletown residents. \$15.00 non-Middletown residents.
- 7) US Swim meet fees must be attached to all meet entry sheets.
- 8) All athletes must be on time for practice and all team meets.
- 9) **Please see Payment Option Plans on the Team Information Sheet.** Payments not received by the due date will be subject to a \$25 late fee. There is a \$10 fee for all returned/non-sufficient checks. There is no prorating of dues.
- 10) Payments received over forty-five (45) days late will result in swimmer's suspension until all fees are paid in full. Accounts must be made current in order for swimmer to be admitted back into the pool.
- 11) **A \$75 work bond per family is required** and will be cashed at the time of registration. To satisfy a work bond, each family will be required to volunteer at a minimum of five (5) ESSL team meets and one (1) session of the US meet that the team will host in February, 2010 at the Middletown High School. All families that satisfy their work bond will have the option of having their work bond refunded to them at the end of the season or may donate the money to the team or to the Woody Memorial Fund.
